1. 30-HOUR CLASSROOM TRAINING PROGRAM* (ALL STUDENTS MUST BE 16 YEARS OLD):

The State of Connecticut, Department of Motor Vehicle (DMV) requires 30 hours of classroom instruction ([which includes the state mandated 8-Hour Safe Driving Practices Program/2-Hour Parent Training Course-Class #9](#))* for eligibility to test 120 days from the learner's permit issue date. **The classroom schedule runs in two-hour increments for a total of 15 classes, 5 per week (4 classes per week during June, July and August), for 3 consecutive weeks (3 1/2 weeks during June, July and August)...1 session per month. If classes are missed during any given session, the curriculum is repeated monthly, so those missed classes can be "made-up" during the following month's session. Just look for the number of the missed class on the following month's schedule, which shows when it's happening again. Remember, there is no time limit for completing this program.**

2. ON-ROAD TRAINING PROGRAM (STUDENT MUST PRESENT PERMIT TO INSTRUCTOR):

DMV requires 8 hours of on-road training for eligibility to test 120 days from the learner's permit issue date. **On-road training runs in 2-hour increments for a total of four 2-hour driving lessons. These lessons are not included in the classroom sessions and must be scheduled separately.** We do our best to pick-up students in a timely manner. However, there will be a delay in returning the student immediately following the lesson because of back-to-back scheduling. The instructor picks up the next student scheduled, and then drops off the previous. If we are delayed in getting to the point of pick-up, the lost time will be made up either at the end of that same lesson, or at a later date. If you are delayed, please try to notify us.

A 24-hour notice of cancellation is required for on-road training! If you do not give ADS a 24-hour notice of cancellation or do not show for a scheduled on-road lesson, a **\$40.00** charge will be incurred.

PLEASE CALL AND SCHEDULE ON-ROAD TRAINING ASAP, AS OUR SCHEDULES BOOK-UP VERY QUICKLY.

F.Y.I. ONLY THOSE STUDENTS THAT COMPLETE THE FULL DRIVER'S EDUCATION PROGRAM, WHICH INCLUDES THE 30 HOURS OF CLASSROOM TRAINING AND 8 HOURS OF ON-ROAD TRAINING ARE ELIGIBLE FOR LICENSE TESTING AFTER HOLDING THEIR PERMIT FOR A MINIMUM OF 120 DAYS, AND MAY BE ELIGIBLE FOR AN INSURANCE DISCOUNT. PLEASE CHECK WITH YOUR INSURANCE CARRIER/AGENT.

3. 8-HOUR DRUG & ALCOHOL/SAFE DRIVING PRACTICES PROGRAM*:

The State of Connecticut, DMV **mandates 8 hours of classroom training for adults (18+) that are first-time driver's license applicants, and for teens, 16/17 years old who do not wish to take the full Driver's Education Program. Insurance discounts WILL NOT be available with this program and student must hold permit for a minimum of 180 days before eligibility for license testing.**

***Includes the 2-Hour Parent Training Course (Class #9) for those students permitted after August 1, 2008. Please see attached schedules.**

4. DMV LICENSE TESTING:

The DMV Inspectors come to ADS on a monthly basis for license testing. After testing, you must wait **48 hours** before going to the **DMV/Wethersfield Branch** for license pick-up. The fee for 16/17 year old students* who take the license test at ADS is **\$60.00**, in addition to the license fee (\$65-\$85).

***License Testing for 18+/Adults must be done at the DMV Branches.**

5. Upon the threat of inclement weather, please tune-in to WVIT/NBC30 (channel 4 on most cable systems), OR go online to www.NBC30.com and click onto "School Closings/Cancellations" for information. On-road training will be suspended if road conditions become dangerous. When on-road training is cancelled, we will call to reschedule that lesson. For classroom training cancellations, the cancelled class will be made-up in the following month's schedule.
